**Supervisor Ryan Skoda: Suzette Booy, Director CC Real Property Tax Service Agency** has sent an email requesting the towns in the county to update their Local Law for Volunteer Firefighter/Ambulance worker Exemption, Town of Taghkanic passed LL 2 – 2023 providing real property tax exemptions for Volunteer Firefighters and Ambulance Workers pursuant to section 466-A of the Real Property Tax Law. To be able to update our Local Law before March 1, 2025 we will need to hold a Public Hearing February 10, 2025. **Board Member Elisabeth Albert** motioned to have a public Hearing February 10, 2025 at 7pm for Local Law 1-2025 providing real property tax exemptions for Volunteer Firefighters and Ambulance Workers pursuant to section 466-A of the Real Property Tax Law with the amended section 466-L of the Real Property Tax Law, seconded by **Board Member Linda Mirabelli**.
